

“DRAKES SUPERMARKETS – Travel Voucher’s July 2023”

HOW TO ENTER

1. To be eligible to enter, individuals must purchase any TWO specially marked product's in one transaction at any participating Drakes Supermarket in South Australia OR Queensland during the promotional period.
2. Participants can enter either by:
 - a. Entry box: complete the entry details as required on their purchase receipt, including their full name, address and phone number, and place in the entry box located in a participating Drakes Supermarket.
 - b. Online: visit www.drakes.com.au/competitions and follow the links to enter your details as prompted. Entrants must keep an original copy of their receipt as proof of purchase.
 - c. myDrakes App: Automatic entry into the promotion is triggered upon scanning your myDrakes App in an eligible transaction at the register during the promotion.

TERMS AND CONDITIONS

1. Information on how to enter and the prize form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to all terms and conditions. Parents/guardians may be required by the Promoter to enter a further agreement as evidence of consent to enter this Promotion.
3. Employees (and their immediate families) of the Promoters, participating Drakes Supermarkets, the Prize Providers and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: parent, sibling, child or spouse.

6. Multiple entries permitted, subject to the following: (a) only one entry permitted per purchase receipt; and (b) each entry must be submitted separately and in accordance with entry requirements.
7. If there is a dispute as to the identity of an entrant, the Promoters reserve the right, in their sole discretion, to determine the identity of the entrant.
8. Promotion commences on 26/7/2023. Final entries close at close of business or 9:00pm (local time) (whichever is first to occur) on 5/9/2023.
9. The prize draw will take place at Drakes Supermarkets Head Office (Level 1, 159 Henley Beach Road, Torrensville, South Australia 5031) on 19/09/2023 at 1pm. The winner's will be notified by mail/email and telephone and posted online at www.drakes.com.au/competitions
10. The Promoters' decision is final, and no correspondence will be entered into.

Except for any liability that cannot be excluded by law, the Promoters and the Prize Providers (including their officers, employees and agents) exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including, but not limited to, where arising out of the following: (a) any technical difficulties or equipment malfunction (whether or not under the Promoters' and/or the Prize Providers control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoters and/or Prize Providers) due to any reason beyond the reasonable control of the Promoters; (d) any variation in prize value to that stated in these Terms and Conditions; or (e) participation in/use of the prize.
20. In the event of war, terrorism, state of emergency or disaster, the Promoters reserve the right to cancel, terminate, modify or suspend the promotion, subject to any written directions from a relevant regulatory authority.
