

**“DRAKES SUPERMARKETS – SNACKBRANDS AUSTRALIA CONSUMER PROMOTION”

HOW TO ENTER

To be eligible to enter individuals must purchase any TWO participating Snackbrands product (CC's, Thins, Kettle, The Natural Chip Co., Cheezels, French Fries, Jumpy's, Samboy, Chickadees, Top 20, Fun Faves Multipack, Tyrrell's and Nice & Natural Bars.) in the one transaction in-store at any participating Drakes during the promotional period. This competition is not able to be entered by online shopping customers.

Participants can enter either by:

- a. Online: visit www.drakes.com.au/competitions and follow the links to enter your details as prompted. Entrants must keep an original copy of their receipt as proof of purchase.
- b. myDrakes App: Automatic entry into the promotion is triggered upon scanning your myDrakes App in an eligible transaction at the register during the promotion.

TERMS AND CONDITIONS

1. Information on how to enter and the prize form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Participation in the promotion is restricted to Australian residents aged 18 years or older.
3. Employees (and their immediate families) of the Promoters, participating Drakes Supermarkets, the Prize Providers and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: parent, sibling, child or spouse.
4. The Promoters reserve the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Errors and omissions will be accepted at the Promoters' discretion. Failure by the Promoters' to enforce any of their rights at any stage does not constitute a waiver of those rights.
5. Incomplete, indecipherable, or illegible entries will be deemed invalid.
6. Multiple entries permitted, subject to the following: (a) only one entry permitted per purchase receipt; (b) only one entry permitted per person per day; and (c) each entry must be submitted separately and in accordance with entry requirements.
7. If there is a dispute as to the identity of an entrant, the Promoters reserve the right, in their sole discretion, to determine the identity of the entrant. The Promoter reserves the right to disqualify entries in the event of non-compliance with these Conditions of Entry. In the event that there is a dispute concerning the conduct of the Promotion, the decision of the Promoter is final and binding on each entrant and no correspondence will be entered into.

10. The Promoters' decision is final, and no correspondence will be entered into.
11. There will be 1 x valid entry per store drawn to win 1 x Limited Edition D-Rake Beach Cruiser Bike with Helmet, valued at \$435 (inc GST) each.
12. Total prize pool is valued at AU \$28,710 (inc GST).
