HOW TO ENTER

TERMS AND CONDITIONS

1. Information on how to enter and the prize form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. **Prize Details and Participation Requirements**

There are five (5) prizes available, each consisting of one (1) ticket for a child to participate as an official Showbag Tester for the Royal Adelaide Show. The Showbag Testing event will take place on **Wednesday, 14th August 2025**, from **9:30am to 12:00noon** at the Royal Adelaide Showgrounds. Plus, one (1) x Family Admission pass to the Royal Adelaide Show 2025.

To be eligible to redeem the prize, the nominated child must be **under 12 years of age** on the day of the event. Each child must be accompanied and supervised by a parent or legal guardian for the duration of the event. Proof of age may be required.

A light morning tea will be provided to attendees. At the conclusion of the event, each child will be able to leave with **two (2) showbags of their choice**.
