

## “DRAKES SUPERMARKETS – JARLSBERG BUY ME TO WIN PROMOTION QLD”

### **HOW TO ENTER**

To be eligible to enter individuals, must during the promotional period, purchase the 500g block of Jarlsberg Cheese from the dairy section (APN number 9310631628445) in the one transaction in-store at any Queensland Drakes Supermarket.

Participants can enter either by:

- a. Website: visit [www.drakes.com.au/competitions](http://www.drakes.com.au/competitions) and follow the links to enter your details as prompted. Entrants must keep an original copy of their receipt as proof of purchase.
- b. myDrakes App: Automatic entry into the promotion is triggered upon scanning your myDrakes App in an eligible transaction at the register during the promotion.

This competition is not able to be entered by online shopping customers.

### **TERMS AND CONDITIONS**

1. Information on how to enter and the prize form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Participation in the promotion is restricted to Queensland residents aged 18 years or older.
