HOW TO ENTER

To be eligible to enter, individuals must during the promotional period, purchase any Lavazza Product in the one transaction in-store at any Drakes Supermarket.

- b. myDrakes App: Automatic entry into the promotion is triggered upon scanning your myDrakes App in an eligible transaction at the register during the promotion.

This competition is not able to be entered by online shopping customers.

TERMS AND CONDITIONS

1. Information on how to enter and the prize form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
