

“DRAKES SUPERMARKETS – LEGGOS WIN A SHARE OF \$5K CONSUMER PROMOTION 2026”

HOW TO ENTER

To be eligible to enter individuals must purchase TWO (2) Leggos, Providore, Raguletto or Five Brothers participating sauce products* in the one transaction in-store at any Drakes during the promotional period.

Participants can enter either by:

- a. Online: visit www.drakes.com.au/competitions and follow the links to enter your details as prompted. Entrants must keep an original copy of their receipt as proof of purchase.
- b. myDrakes App: Automatic entry into the promotion is triggered upon scanning your myDrakes App in an eligible transaction at the register during the promotion.

TERMS AND CONDITIONS

1. Information on how to enter and the prize form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Participation in the promotion is restricted to South Australian and Queensland residents aged 18 years or older.
3. Employees (and their immediate families) of the Promoter, participating Drakes Supermarkets, the Prize Providers and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: parent, sibling, child or spouse.
4. The Promoter reserve the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Errors and omissions will be accepted at the Promoters discretion. Failure by the Promoter to enforce any of their rights at any stage does not constitute a waiver of those rights.
5. Incomplete, indecipherable, or illegible entries will be deemed invalid.
6. Multiple entries permitted, subject to the following: (a) only one entry permitted per purchase receipt; (b) only one entry permitted per person per day; and (c) each entry must be submitted separately and in accordance with entry requirements.
7. If there is a dispute as to the identity of an entrant, the Promoter reserve the right, in their sole discretion, to determine the identity of the entrant. The Promoter reserves the right to disqualify entries in the event of non-compliance with these Conditions of Entry. In the event that there is a dispute concerning the conduct of the Promotion, the decision of the Promoter is final and binding on each entrant and no correspondence will be entered into.

The winners will be notified in writing and via phone within 7 days of the prize(s) being drawn and the winners details (last name, first initial and postcode) posted online at www.drakes.com.au/competitions/competition-winners.
10. The Promoters decision is final, and no correspondence will be entered into.
